Amongst the matters discussed recently were the formal understanding with the County Council namely the Compact (which can be seen on Medrwn Môn's website), the County Council's volunteering policy, access for the voluntary sector to be part of the County Council's scrutiny process. To the future the Funding Code of Practice between the County Council and the voluntary sector will need to be discussed.
